For what purpose and on what basis we process personal data

Dutch Mushroom Projects BV processes your personal data for the following purposes: - Handling your payment - You can call or e-mail if necessary to carry out our services - inform you about changes to our services and products - To deliver goods and services to you - Dutch Mushroom Projects BV analyzes your behavior on the website in order to improve the website and to tailor the range of products and services to your website preferences. - Dutch Mushroom Projects BV also processes personal data if we are legally obliged to do so, such as information we need for our tax return.

Automated decision-making

Dutch Mushroom Projects BV does not take decisions based on automated processing on matters that can have (significant) consequences people. These are decisions taken by computer programs or systems, without a person there (for example, a Dutch employee Mushroom Projects BV) in between.

How long we store personal data Dutch Mushroom Projects BV does not store your personal data longer than is strictly necessary to achieve the purposes for which your data is collected.

Sharing personal data with third parties

With companies that process your data in our assignment, we conclude a processor agreement to take care of the same level of security and confidentiality of your data. Cookies, or similar techniques, that we use

View, modify or delete data

For protecting your privacy, please make your passport photo in this copy, MRZ (machine readable zone, the strip with numbers at the bottom of the passport), passport number and citizen service number (BSN) are marked black. We will respond as soon as possible, but within four weeks, after your request.
